#### Appropriate engineering controls

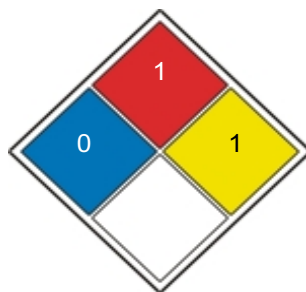
