Appropriate engineering controls

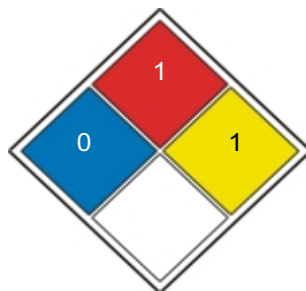
